With the completion of training and certification of the Flying Pilates Teacher Training Program, the trainees will set into practice a quality-based approach and philosophy of Flying Pilates, as well as ensure its implementation in line with its originator, Sonja Ehrlich and agree to the following general conditions herein.

Content

- 1) The Flying Pilates UG (Limited Liability) offers courses for the Flying Pilates Teacher Training program. Upon full participation in the training and upon obtaining the certificate, the trainee is entitled to call him/herself a Flying Pilates Trainer and to teach Flying Pilates courses. The courses are called "Flying Pilates. If the trainer offers different difficulty levels, the description is divided into the levels "Basic", "Mix" or "Regular".

The "Basic" level consists of an introductory course with simple exercises and an intensive explanation and practice phase.

The "Mix" level offers exercise variations so that beginners and advanced level participants can participate equally.

In the "Regular" level, the exercises are more demanding in the requirements for body tension, sensation and strength.

- 2) The right to train Flying Pilates trainees or offer a Flying Pilates Teacher Training program is exclusively for Flying Pilates UG (Limited Liability). The Trainer is not allowed to train other trainees. The Trainer is also not entitled to transfer rights of use to third parties or grant sub-licenses.
- 3) All training materials and course content is provided by Flying Pilates UG (Limited Liability); are solely for the personal use of the participant and are the property of the Flying Pilates UG (Limited Liability). The documents may not be reproduced or transmitted to third parties.
- 4) The Trainer will teach Flying Pilates only in studios registered with the Flying Pilates UG (Limited Liability). A registration is free for studios and can be initiated by the Trainer or by Flying Pilates UG (Limited Liability).
- 5) The Trainer is entitled only to use the Flying Pilates logo to advertise his/her course offers online or in print. However, the logo may not be used beyond that, such as for promotional material or merchandising items. Any other use of the logo requires the written consent of Flying Pilates UG (Limited Liability). A change of the logo is not permitted.

- 6) The Trainer may only present the Flying Pilates Program as part of his/her self or studio presentation. Presentations by or on behalf of Flying Pilates at workshops, congresses, other events or in publications require the written consent of Flying Pilates UG (Limited Liability). The amount of Flying Pilates content may not exceed 30% of the total course or presentation offer.
- 7) The instructor must inform Flying Pilates UG (limited liability) of any changes to his contact details.
- 8) (If not desired, please strike through.)

The trainer agrees to use of the data marked with an * in the Trainee Information section above in the List of "Certified Trainer" on the website www.flying-pilates.de.

1. For the link / inclusion, an annual one-time payment of € 129, - (including VAT) is due. The trainer will receive an annual invoice for the amount due.
 2. The trainer is responsible for the correctness of the data. Changes are possible at any time and can be communicated by email or in writing. The changed data is then integrated within one week.
 3. The link / inclusion is extended by a another year, if it is not terminated three months before the end of the respective signing. The cancellation can be made online (by email) or in writing.
 4. The termination of the link / inclusion on the website does not affect the other provisions of the Framework Agreement.
 5. Flying Pilates UG (Limited Liability) will ensure that the specified data of the trainer is available during the year on the www.flying-pilates.de website. (Falls nicht gewünscht, bitte streichen.)
- 9) Should one or more provisions of these General Terms and Conditions be or become invalid, the effectiveness of the remaining provisions shall not be affected thereby.
